INTERIM INJUNCTION

COURT AND LIABLE TO A TERM OF IMPRISONMENT AND/OR FINE**

IMPORTANT

NOTICE TO THE RESPONDENT

- (1) This order prohibits you from doing the acts set out in this Order. You should read it carefully. You are advised to consult a solicitor as soon as possible. You have a right to ask the Court to vary or set aside this order.**
- (2) If you disobey this order you may be found guilty of Contempt of Court and may be sent to prison or fined.**

On the 28th June 2011 the court considered an application for an injunction.

ON HEARING Clare Parry of Counsel for the Claimant.

AND ON READING the witness statement of Stephen Lawrence dated the 27th June 2011.

IT IS ORDERED that

- (1) The Defendant whether by himself, his servants or agents or otherwise howsoever shall be forbidden from using or permitting the use of 13 Grosvenor Road, Southampton, SO17 1RU ("the Premises") for in excess of six residential occupants who do not form a single household (as defined by section 258 of the Housing Act 2004), without the express grant of planning permission (save as provided for in 2).
- (2) In the event that at the time of grant of this injunction there are more than six people in occupation of the Premises this injunction will have effect only to forbid the Defendant from using or permitting the use of 13 Grosvenor Road for occupation by any further persons who are not in occupation at the time of the grant of the order, and will not require the Defendant to prevent the occupation of the Premises by those already in occupation at the time of the grant of the Order.

This order shall remain in force until the 5th JULY 2011 10.30 am, when it shall be further considered by the Court, unless before then it is revoked by a further order of the court.



Service of the Order

- (2) This Order along with the Claim Form and other documents in the Claim shall be served (i) personally on the Defendants, so far as reasonably practicable, and (ii) by affixing copies to the main entrance door to the Premises, and that it shall be deemed to be good service if (ii) is complied with.

Costs of the Application

- (3) The costs of the Application be reserved.

Variation or discharge of this Order

The Parties may apply to the Court at any time to vary or discharge this Order on ~~48~~²⁴ hours ^{written} notice.



Interpretation of this Order

It is a contempt of Court for any person notified of this Order knowingly to assist in or permit a breach of this Order. Any person so doing may be sent to prison, fined or have his assets seized.

The effect of this Order

The Defendant who is an individual who is ordered not to do something must not do it himself or in any way. He must not do it through others acting on his behalf or on his instructions or with his encouragement.
