

### 1.Reported incidents since the last HRA Committee Meeting of 7 October - (24+)

There have been 24+ reported incidents since the last HRA Committee Meeting on 7 October. This is an increase of 20+ incidents. However, the list of current incidents dates from 7 October, covering 2 months instead of one.

#### (i)Incidents in Portswood - (10+)

- Street drinkers with open cans/bottles using seating area outside the former Flagship Coffee (2)
- Street drinkers using the seating area outside 'Hotpot', opposite the Trago Lounge (2)
- Cyclist speeding through Portswood Library pedestrian crossing on red traffic light. Nearly hit a member of the WhatsApp Group (1)
- Person nearly ridden into on pavement by young man on illegal scooter. When the victim said they should not be riding on the pavement, the scooter rider threatened them with violence (1)
- Motor scooter rider, with bright design 'Rick's MOT' on the back, went through an orange/red light outside Sainsburys main pedestrian entrance (1)
- 'Bed' outside Farm Foods removed by Community Safety (1)
- 'Bedding' and many other items outside the former Iceland Store (now Chinese shop) removed by Community Safety (1)
- Cancer Research UK charity shop broken into and £2 taken from the donations pot; the Mountbatten charity shop had a big crack in the window; The Muse's glass was smashed (1)

# (ii) Incidents reported away from Portswood Broadway - (10+)

- Handbag stolen in town (1)
- Driver drove at speed the wrong way round a traffic calming point in Westwood Road (1)
- Suspicious man wandered down some driveways in Brookvale Rd, claiming to be picking someone up but was caught on CCTV taking something from a garden (1)
- Rented garage in Richmond Gardens broken into twice and items stolen the first time round (2)
- Student 'moving' parties for several nights a week over a few weeks in October in Blenheim Gdns, Upper Shaftesbury Ave, Welbeck Ave, Highfield Crescent and other areas. Groups of 50 or so students proceed along pavement chanting/shouting. They spend about half an hour in the back garden of one house before heading off to the next house, and the next etc, etc. A noisy and cumulative effect. (1+). See (2) below for actions that can be taken
- Two car accident Church Lane on 28/11/25 school pick up time: both cars tried to get through road buildouts with inevitable collision. School collecting evidence; lots of witnesses. Can use this link for witness

- Car waiting regularly on double yellow lines outside school for pick up. Can use this link to report parking offences (1)

- Accident on 25/11/25 at the junction of Highfield Lane and Brookvale Road involving a police vehicle
  responding to an emergency and a member of the public. There were no injuries reported and only
  minor damage to the police vehicle and roadside furniture (1)
- Yuki, 6 month old Maine coon cross, was lost. Later found (1)

# 2. Reporting student parties / disruption (from ii above)

Barbara received this helpful response from Sonia Cottrell, Chief Executive of SUSU:

"Paddy has taken over Jon's role (although I think he is intending to appoint someone with more direct responsibility for this part of the role) so in general terms you should contact Paddy whenever you would previously have contacted Jon.

However, for any incidents or behaviours connected to clubs and societies, you should feel free to contact me. Clubs and societies are part of the Students' Union and we will act on any complaints received (if students are on an official club/society social, they will generally be identifiable by hoodies and T-shirts). We do emphasise the need to be good neighbours when we do committee training but I will ask the team to remind clubs and societies about this, just in case any of the incidents your members are complaining about are related."

# 3. Shoplifting in Boots

In October, a member reported that she saw a man who looked as though he was filling his rucksack with items from the shelves in Boots Portswood. She learned that Boots staff have been told that they must not intercept anyone who might be stealing. They say they have 14 – 15 incidents of shoplifting by the same people each day. The police usually arrive hours after any reported event and cannot do anything. I contacted PC Adam O'Neill for feedback on the above and received the following helpful response:

PC Adam O'Neill: "Boots do not routinely report every incident as an active theft; they frequently report incidents retrospectively rather than calling police at the moment they occur. When Boots (or any business) reports an active shoplifting, attendance depends on police resourcing and priorities at that given time, so we are not always able to attend every live incident, although we do attend when possible. That being said, every reported shoplifting in Portswood is followed up by PC Pollicott, our designated shoplifting officer. Follow-up enquiries include reviewing CCTV, taking witness statements, and other investigative steps to progress each case."

I later asked PC Adam if the App below, described on the BBC website on 27 November, is in use in Portswood. His helpful response is in italics below (information on the App was given to me by Christine R). A crime-fighting app which has helped police tackle shoplifting is being expanded to cover anti-social behaviour around pubs and clubs: "The UK Partners Against Crime (UKPAC) app allows shop owners to

share information about known offenders with each other and the police. The app will now be rolled out to night-time venues to help them identify and ban prolific troublemakers. Hampshire and Isle of Wight's Police and Crime Commissioner (PCC) Donna Jones said the app had helped secure 45 years' worth of prison sentences for shoplifting offenders." <a href="https://www.bbc.co.uk/news/articles/c1dzp7966zxo">https://www.bbc.co.uk/news/articles/c1dzp7966zxo</a>

Response from PC Adam O'Neill: "I can confirm that UKPAC is used in Portswood. It supports our response to shoplifting not only within Portswood itself, but across the wider force area. While it's a helpful tool that enhances the efficiency of how we manage and share information, it's not something we rely on exclusively rather, it works alongside our existing policing methods. Regarding any plans to expand the app's use to cover antisocial behaviour around pubs, clubs, or the night-time economy, I'm afraid I'm not aware of any such developments. I haven't heard anything to suggest this is currently being considered, so I can't offer further detail on that aspect."

#### 4. Public Space Protection Orders (PSPO)

New Public Space Protection Orders (below) have been signed off by the City Council Cabinet, this includes for Portswood. These strengthened Orders replace those that lapsed at the end of April 2025, which only covered street drinking. We understand that the PSPOs will come into force once the signs have been installed. We understand that these must be in place prior to the PSPOs going live. This could be before Christmas.

From SCC Facebook page, Thursday 27 November 2025:

'Southampton City Council's Cabinet has approved new Public Space Protection Orders (PSPOs) across five areas of the city. The PSPOs are designed to make Southampton safer for residents, workers, and visitors and address street drinking, aggressive begging, and drug and psychoactive substance.

Councils can use PSPOs to prohibit specific activities or require certain things to be done by people engaged in particular activities within a defined public area.

The PSPOs cover Shirley, Portswood, Bitterne, City Centre, and Woolston. Enforcement will be led by police officers, with Southampton City Council authorised to appoint additional officers. The new PSPOs will be in effect for three years, up to September 2028.

Southampton City Council's decision follows feedback from the Safe City Survey. This revealed overwhelming support for the new measures, with 93% backing controls on street drinking, and 97% supporting action on aggressive begging and drug use.

While enforcement is a priority, Southampton City Council emphasises education and support for those affected by substance use and homelessness. Fixed penalty notices may be issued, but the focus remains on helping individuals access services and support.

New signage will be installed across the five areas, funded by the UK Shared Prosperity Safer Streets Fund. Southampton City Council will continue to work with partners to monitor the impact of the PSPOs and ensure Southampton remains a safe and welcoming city for all.'
